



FREQUENTLY ASKED QUESTIONS

WHAT IS A BRACKET?

A bracket is comprised of teams that have qualified to participate in the NCAA Men's Basketball Tournament. The single-elimination tournament results in two teams competing in the Championship Game on Monday, April 6, 2026. To fill out your bracket, simply select the teams that you think will win each game during the tournament up to the Championship Game. If you are a basketball novice, you can use either our PICK FOR ME button to fill out your bracket with randomly selected teams or our FAVORITES button to fill out your bracket with the highest-seeded teams. Regardless of how you fill out your bracket, be sure to click SUBMIT after you are done to ensure that your bracket is recorded in the system.

WHAT IS A \$100,000 PROP CARD?

The Prop Card is a 25-question quiz about the Semi-Final and Final Championship games played Saturday, April 4 and Monday, April 6, 2026. Try to predict the answers to the Prop Card questions by clicking on the answers you think will be correct. If you get all 25 questions correct, you win up to \$100,000.

HOW CAN I EARN BONUS BRACKETS AND/OR PROP CARDS FOR EXTRA CHANCES TO WIN?

Make minimum \$100 sports wagers at Spirit Mountain Casino to receive a Champions Code card for each qualifying wager. Enter the code(s) online to receive the bonus brackets or Prop Cards. Limit five (5) bonus brackets and five (5) bonus Prop Cards per player.

HOW DO I ACTIVATE BRACKETS, PROP CARDS AND DRAWING ENTRIES TO BE ELIGIBLE TO WIN?

Brackets must be activated to be eligible to win any bracket prize. Activate your brackets by swiping your Coyote Club card at any promotional kiosk once, March 16 – 22, 2026.

Prop Cards must be activated to be eligible to win any Prop Card prize. Activate your Prop Cards by swiping your Coyote Club card at any promotional kiosk once, March 30 – April 3, 2026.

Drawing Entries must be activated to be eligible to win any prize in the April 6, 2026, Virtual Championship Game drawing. Activate your entries by swiping your Coyote Club card at any promotional kiosk once, April 1 – 5, 2026.

AT WHAT TIME DO EARNING ACTIVITIES RESET EACH DAY?

\$1,000,000 March Mania earning activities are reset at Midnight.



OFFICIAL PROMOTION RULES

PROMOTION OVERVIEW

Spirit Mountain Casino's \$1,000,000 March Mania promotion runs from Tuesday, March 3, 2026, to Monday, April 6, 2026. Coyote Club members will pick who they think will win all games in the NCAA Men's Basketball Tournament. Participants have one or more chances to win up to \$1,000,000 cash for a perfect, activated bracket (i). They also have one or more chances to win up to \$100,000 for submitting a perfect 25-question prop card about the Semi-Final & Championship Games (ii). The promotion concludes with a Virtual Championship Game Drawing (iii) with a prize pool of \$3,350 Free Play. Gamification emails (iv) will be sent once per week to keep the players engaged.

Details:

Promotion period is Tuesday, March 3, to Monday, April 6, 2026.

BRACKETS AND LEADERBOARDS (i)

A **\$1,000,000 Bracket** is comprised of the 64 teams that have qualified to participate in the NCAA Men's Basketball Tournament. The single-elimination tournament results in two teams competing in the Championship Game on Monday, April 6, 2026. The campaign tips off with participants selecting winners for all games throughout the tournament.

Picks can be made online from Sunday, March 15, 2026, to Wednesday, March 18, 2026. Participants are awarded points, which increase in value with each round, for every correct pick they make.

The deadline to submit \$1,000,000 Bracket picks is 11:59pm on Wednesday, March 18, 2026.

Bracket scoring

Each correctly picked winner of a tournament game will award bracket point(s). The brackets with the most points at the end of the tournament will win. Bracket points per win are as follows:

- a. Round of 64: 1 point per each correct winning team
- b. Round of 32: 2 points per each correct winning team
- c. Round of 16: 4 points per each correct winning team
- d. Round of 8: 8 points per each correct winning team
- e. Round of 4: 16 points per each correct winning team
- f. Championship: 32 points for selecting the national champion

To be eligible to win the \$1M or any leaderboard prize, bracket picks must be activated. Activation consists of a single kiosk swipe at a Spirit Mountain Casino promotional kiosk once, between Monday, March 16 and Sunday, March 22, 2026. Brackets submitted – but not activated – do not appear on the leaderboards and cannot win any leaderboard prizes.



A ‘perfect bracket’ is defined as a player picking every winning team for every game and scoring 192 points. The bracket must have been activated at any promotional kiosk between 12am Monday, March 16, and 11:59pm on Sunday, March 22, 2026. There is a maximum of ONE prize of \$1,000,000 cash available. In the case of two or more players submitting a perfect bracket and meeting all eligibility requirements, the \$1,000,000 prize will be split equally among all winners across all entities and contests participating in the insurance pool; prizes are not exclusive to Spirit Mountain Casino and its guests.

All pre-registered players receive one free Million Dollar Bracket on Selection Sunday (March 15, 2026), the day the competing teams are announced. Anyone who was not pre-registered and chooses to self-register online by Wednesday, March 18, 2026, will also receive one free Bracket.

Championship Codes

Players may earn additional brackets with Champions Codes. Champions Codes can be earned with each \$100 qualifying sports wager at the sportsbook counter and sports kiosks from March 3 – March 12, 2026. All Champions Code cards will be issued at the Coyote Club. A qualifying sportsbook receipt will be highlighted and initialed to indicate the Champions Code has been issued. The Coyote Club rep will mark the guest off in Pinpoint to track the total number of cards issued (not to exceed five per person).

Champions Codes for bonus brackets can be entered online from Tuesday, March 3 – Thursday, March 12, 2026, for a bonus bracket, limit five per player. (Championship Codes can be entered March 19 through 26 for the Prop Card Challenge, details in following section.)

Leaderboard Prizes

Leaderboard Prizes will be awarded on March 23 and March 30, 2026, to the top three participants who selected the most winning teams and activated their brackets. Prizes must be claimed within 14 days, or the prize is forfeited.

This tie-breaker rule will apply to all ties other than a tie for perfect brackets:

In the case of a tie between players' brackets, the winner will be determined by the date and time of submission. The player with the earliest time of submission will be deemed the winner. Example: Two brackets total 52 points each, one submitted at 5:30pm on March 16, 2026, and the other at 11:50am on March 18, 2026. The earlier of the two (5:30pm, March 16, 2026) will be declared the winner. In the event of a submission-time tie, a random drawing will occur among all tied participants.

Free Play prizes will be automatically issued to the guest's account. Free Play will expire 30 days after being issued.

\$100,000 CHAMPIONSHIP CHALLENGE (Prop Cards) (ii)

Players will have the opportunity to answer a twenty-five-question Prop Card, which awards an insured prize of \$100,000 cash for getting all twenty-five questions correct. The simple questions are based on the Semi-finals and Championship games. Players may submit Prop Cards online from Monday, March 30, 2026, through Friday, April 3, 2026.

To be eligible to win up to \$100,000, Prop Cards must be activated at Spirit Mountain Casino with a single kiosk swipe once between Monday, March 30, 2026, and Friday, April 3, 2026. Prop Cards submitted but not activated are ineligible to win any Prop Card prize.

All participants who click in the Prop Card section of the website from March 30 – April 3, 2026, will receive one free \$100,000 Prop Card.

Players may earn additional Prop Cards with Champions Codes. Champions Codes can be earned with each \$100 qualifying sports wagers at the sportsbook counter and sports kiosks from March 19 – March 26, 2026. All Champions Code cards will be issued at the Coyote Club.

Champions Codes can be entered online from Thursday, March 19 – Thursday, March 26, 2026, for a bonus prop card, limit five per player.

Only the best-performing Prop Card can win a prize; one prop card prize per player.

Prop Card scores will be posted online on Tuesday, April 7, 2026. Based on the number of correct answers, players will be awarded:

If a guest scores 25 of 25 correct answers on their prop card, they will win the \$100,000 insured prize. There is a maximum of one prize of \$100,000 cash available. In the case of two or more players submitting 25 correct picks and meeting all eligibility requirements, the \$100,000 prize will be split equally among all winners across all entries and contestants participating in the insurance prize pool; prizes are not exclusive to Spirit Mountain Casino and its guests. Winning prop cards must be verified and meet all eligibility requirements.

\$100,000 insured prize must be claimed at the Coyote Club within fourteen days, or the prize is forfeited.

GAMIFICATION EMAIL & INSTANT REWARD (iv)

The Million Dollar March Mania Challenge features gamified emails that engage the players by logging them in to an online portal and provides them a "rewarding" game to play once each week. After playing the game,



each player wins an *Instant Reward*, which they must claim at the property.

A list of the winners and the corresponding prizes won will be sent to the Marketing Department and will be uploaded into the promotional kiosks. Guests will have from Tuesday – Monday of each week to redeem their Instant Rewards at the promotional kiosks. Prizes include Food and Free Play and are varied by the guest tier.

GENERAL RULES
